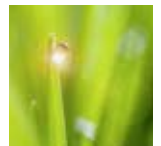

GOJO practices water conservation by using low-water consuming fixtures in its offices and manufacturing operations. We purchase environmentally-sustainable office furniture and supplies. Furniture, computer and electronic equipment, toner cartridges, paper, cardboard, pallets, plastic bottles, steel/metal, fluorescent bulbs, and batteries are all recycled or reused.

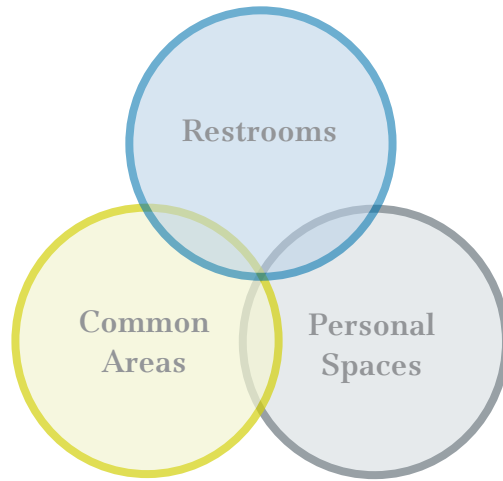

WHY ARE BIOBASED PRODUCTS IMPORTANT TO THE ENVIRONMENT?

Biobased products are defined by the USDA as products composed in whole or in significant part, of biological products or renewable domestic agricultural materials. The Farm Security and Rural Investment Act of 2002, Section 9002 required the USDA to develop a preferred procurement program for biobased products.



The Farm Security and Rural Investment Act of 2002 directed the USDA to develop regulations that:

- Enhance the nation's energy security by substituting biobased products for products derived from imported oil and natural gas
- Increase domestic demand for biobased product
- Spur development of the industrial base through agricultural processing and manufacturing in rural communities.

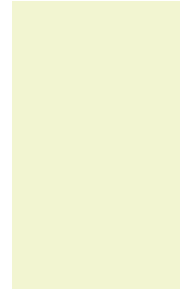
