## DIRECTIONS FOR USE

For use with WAXIE Solution Station® dispensers.

**Dilutions:** For maximum coverage, it is recommended using with the WAXIE Dry Vapor Smoke and Odor Eliminator. Product is highly concentrated and the recommended dilution ratio is 1:16 or 8 oz. per gallon of water. Dilute in bottle fill mode only.

**Room Deodorizing:** Using any one of the three Solution Station dispensers in bottle fill mode only, fill spray bottle with diluted product and mist room, drapes and upholstery.

**Carpets:** Dilute 1 part concentrate to 16 parts of water. Spray onto surface at a rate of 1 gallon per 500 square feet. NOTE: It is not necessary to clean the carpet in order to eliminate odors. Persistent odor may require injection of straight concentrate into the center of the carpet. This product can be used as a pre-treatment prior to extraction or shampooing. Dilute 1 part concentrate to 16 parts of water. Allow solution to penetrate for 15-20 minutes and proceed with cleaning the carpet.

Turn off water supply after use and disconnect.

**DILUTION RATIO:** 1:16 (8 oz/gl) of water in bottle fill mode. Each bottle makes 14 gallons. Each case makes 54 gallons.
